### WORLD HEMOPHILIA DAY 2019 **OUTREACH AND IDENTIFICATION**

World Haemophilia Day was celebrated around the world on 17 April 2019. This year, the World Federation of Hemophilia (WFH) focussed on reaching out and identifying new members of the bleeding disorders community. For many years, the WFH has supported outreach projects in different countries and conducted educational events for both lay and health care professionals in conjunction with our national member organizations (NMOs).

The WHD2019 campaign featured examples of WFH outreach initiatives such as organising regional workshops, raising awareness of bleeding disorders through media coverage or training health professionals and collecting data. It combined these examples with submissions from our community about outreach efforts in their own regions or ideas about what would be helpful for future initiatives.

This landmark day also helped to illustrate the importance of the WFH Humanitarian Aid Program—an important endeavour for the WFH that provides a range of integrated care development training programs to ensure the local infrastructure and medical expertise are available to optimize and appropriately use donated products.

# **HFA Ageing Project**

HFA has received funding from the Australian Government Department of Health to investigate the needs of the bleeding disorders community around ageing and try out some solutions relating to education and peer support and has recruited Preetha Jayaram to lead the project and will be in contact with community members, HTCs and other stakeholders to consult about ageing issues.

With her diverse set of skills and background, Preetha is looking forward to taking on the Ageing project with HFA. She began her career as a social scientist and anthropologist conducting research into castes, tribes and rural development in Kerala State in India.



'After migrating to Australia in the early 1990s, I continued my research career working with Melbourne's local government community services departments on ageing projects,' said Preetha. 'This involved visiting and talking with many older people in the community – in one project we interviewed around 500 older residents!'

Preetha then moved on to curatorial work and digitising the indigenous collection at Museum Victoria. She also had the opportunity to undertake research and community consultations for the Stolen Generations organisation in Melbourne.

More recently, Preetha has followed her interest in education and has gained qualifications and expertise in education program design and content development for the Vocational Education and Training (VET) sector. She currently also works part-time as the Training and Compliance Manager for a vocational education provider in Melbourne.


'I love interacting with people and listening to their stories. I have a strong belief in using personal stories to understand and empower the community.'

# Extended Half Life Clotting Factor Products included in National Blood Arrangements

#### Inclusion of Extended Half Life Clotting Factor Products in National Blood Arrangements

The National Blood Authority (NBA) announced that they will include Extended Half-Life (EHL) factor VIII and factor IX products - treatments for haemophilia A and B - in the next national tender for clotting factors and related products. The tender is currently planned for 2019.

The Jurisdictional Blood Committee (JBC) recently approved the inclusion of EHL recombinant factor VIII and EHL factor IX products in the national arrangements for funding and supply of blood products managed by the NBA. The JBC decision was supported by a Medical Services Advisory Committee (MSAC) assessment of EHL recombinant factor VIII and factor IX products.

The NBA confirmed that the current arrangements for EHL clotting factor products will continue in the meantime. These arrangements provide temporary access to EHL products for approximately 200 haemophilia patients with high priority needs. # **Arved Wasser Memorial Fund**

#### INFORMATION AND APPLICATION FORM

HFWA invites applications for the Arved Wasser Memorial Fund for the 2019/2020 financial year. If you would like to apply to the fund please complete the Standard Form of Application, and return to HFWA no later than Friday 31 May 2019.

The Fund was established to give people with a bleeding disorder access to limited financial assistance, should they wish to pursue any educational, recreational, or work related study or activity. Conditions are explained in the guidelines. Criteria for eligibility may loosely be described as any means of "self-betterment".

#### Guidelines

- a) For such time as the fund remains sustainable, a nominated sum (e.g. \$1,000) shall be made available each financial year. This amount may be reached by way of a single grant, or several smaller grants.
  - b) These grants will consist of a nominated sum from the Arved Wasser Memorial Fund, and an amount being equal to this sum, (i.e. 50% of total) coming from HFWA general funds.
  - c) Monies to be available for these grants, and any conditions hereto, shall be decided at the sole discretion of HFWA committee.
- The recipient of any grant from this fund must reside in Western Australia, and have a bleeding disorder. Family members (including carriers) are not eligible.
- a) Members will be invited to make application, (e.g. notice in newsletter) however; financial membership of HFWA shall not be a prerequisite for any applicant.
  - b) HFWA shall define a period of time in which applications should be lodged each year. At the conclusion of this period, fair and equal consideration will be given to all applications. If none are received, or approved within the allotted time, applications may be lodged any time until the end of the current financial year.
  - c) If, in any financial year that the fund is operating, no grants are approved, or the total of those approved is less than the sum nominated by the HFWA committee, such monies shall remain in the fund to be "rolled over" into the following financial year. They shall not be available for any other purpose, unless so designated by HFWA committee.

- 4. Applications should be made by the person concerned or in the case of a minor, by a parent or legal guardian.
- 5. The sitting committee of HFWA shall consider each application according to individual circumstances. A decision on any application (s) shall be at the discretion of said committee. Any such decision will be final.
- These grants are not intended to subsidise regular primary or secondary school fees, with regard to "every day" school curriculum. Additional tuition or courses, or skill building activities (e.g. photography, music or scuba diving) may qualify.
- 7. There shall be no restriction on how the grants may be used, with regard to further education, such as TAFE or university courses.
- 8. These grants are not intended for medical treatments or procedures.
- 9. These grants may be given for sporting or recreational activities. There shall be no restriction on how the grants may be used. However, preference will be given to an applicant seeking assistance (e.g. travel or equipment subsidy), in order to attend a special event such as a major championship, training facility, seminar or meeting, in relation to their chosen sport or activity.
- 10. Wherever and whenever possible, monies from these grants shall be paid directly to the "third party" involved (i.e. the person or body providing the goods or services being considered). Unless presented with exceptional circumstances, monies will not be paid to applicants.

- Funding may be provided at the discretion of the HFWA Management Committee.
- Financial members only may apply to receive assistance from this fund.
- Members should not see funding support as an automatic right.
- Assistance can be provided only if funds are available at the time of the request and all application criteria are met.
- Alternative avenues of funding assistance should be sought prior to requests being submitted to HFWA.
- Strict confidentiality is applied to all requests.
- Forms with the original application are stored securely at the HFWA office for accountability and auditing purposes only.
- HFWA will fund a maximum of Conference registration costs including farewell dinner, two night's accommodation and one economy return airfare.
- Previous applications for assistance will be taken into account.
- All applications to be made using the relevant form (copy attached), through the HFWA Committee members or Office Coordinator.
- If required, further information may be sought from HFWA Committee Members.
- Successful applicants are required to write an article about their experience at the conference for the HFWA newsletter.
- HFWA Management Committee will assess each application on its merit and its decision is final.
- Intending funding applicants/attendees must pay their expenses prior to reimbursement by HFWA
- Re-imbursement will be made to approved applicants once receipts have been provided. Discretion of the Management Committee can be applied at any time.
